This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

SUMMARY

This bill would have repealed the limits on municipal regulation of mobile homes and mobile home parks, and would have required them to be subject to the same municipal regulations and requirements as single-family dwellings and developments of single-family dwellings.

SUMMARY

Current law requires election materials to be retained for 22 months to serve as evidence in any fraud investigation. This bill would have permitted a memory pack, which is the computer program that counts ballots in a voting machine, to be reused in an election that occurs within the 22-month retention period as long as the municipality has a written copy of the computer program.

SUMMARY

Under this bill, a person would have been guilty of the crime of theft of services if the person retained possession of rental property after the expiration or termination of the tenancy, knowing that to do so was to obtain a service available only for compensation, by a means designed to avoid due payment for the service.

Committee Amendment "A" (H-212), the minority committee report, would have provided that a person committed theft of services if the person vacated the property without notice before the end of the lease, by a means designed to avoid paying for the remaining lease term.

SUMMARY

This bill would have allowed wholesale liquor sellers to extend credit to retail liquor sellers for 30 days for the purchase of malt beverages and table wine.
