All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

SUMMARY

This bill ensures that the Department of Mental Health and Mental Retardation will provide assessments of patients at the Augusta Mental Health Institute and the Bangor Mental Health Institute in the time frames identified by Public Law 1989, chapter 501, Part BB, section 7, and that such assessments will comply with the terms and conditions of the consent decree to avoid the need to provide multiple assessments from the 2 mandates.

Committee Amendment "A" (S-44) gives the Department of Mental Health and Mental Retardation additional time to comply with the assessment requirement. It also adds an emergency preamble and fiscal note to the bill.

SUMMARY

This bill proposes a 2-year demonstration project in which short-term nursing and boarding home respite care services are made available to Medicaid eligible clients. The Department of Human Services reimburses facilities chosen through a request-for-proposals process at their current rates to hold open beds for respite care clients.

SUMMARY

During the 114th Legislature, a law was passed which barred the Department of Human Services from prohibiting the use of cloth diapers in day care facilities if the facilities employed a professional diaper laundering service. This bill removes the requirement that a laundering service be used and allows cloth diapers without restriction.

Committee Amendment "A" (H-95) replaces the original bill. It repeals the current requirement that allows the use of cloth diapers if a diaper laundering service is used and replaces it with a requirement that rules be adopted by the Department of Human Services that address the use of diapers in licensed day care facilities and registered home baby-sitting services.
