SUMMARY

This bill establishes a small community air service program, administered by the Department of Transportation, to promote intrastate air service to small communities with limited air service. The cost of air service subsidies is shared by the State and by the community desiring new air service.

Committee Amendment "A" (H-269) allows the Department of Transportation to administer a subsidized air service program to small communities with limited air service, but does not require it to do so. The amendment allows the Department to allocate subsidies between the State and the community desiring new air service within the funding available. The amendment requires the department to establish a pilot air service subsidy program in 1992 if funds are available. The amendment also adds a fiscal note to the bill.

SUMMARY

The bill makes necessary changes in the law to allow the State's entry into the International Registration Plan or IRP. The IRP is a commercial registration apportionment agreement in effect among 45 states. This bill provides for a continuation of staggered registrations and a means of transition into the agreement. Minor fee adjustments are also made.

The bill makes the State's basic trailer registration a nonapportioned administrative fee under the IRP and provides for 2-year trailer registrations at twice the annual fee. Additionally, the bill corrects an obsolete reference to the Public Utilities Commission. The Secretary of State administers this program.

Committee Amendment "A" (H-268) corrects a section of the Maine Revised Statutes, Title 29 erroneously cited in the bill. The amendment also adds an allocation and a fiscal note.

This bill provides the current services allocations from the Highway Fund and certain other funds for FY 1991-92 and 1992-93. The first year allocation is approximately \$361,250,000 with 1,967 positions (legislative count), distributed as follows.
