This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

**LD 1016**    **An Act Relating to Distribution of Retirement Benefits in Divorce**

**CARRIED OVER**

**SUMMARY**

This bill requires the Maine State Retirement System to accept and enforce a court-ordered retirement benefits division when the division ordered is incident to a divorce or judicial separation or it is necessary to satisfy a spousal support obligation.

The bill was carried over to the Second Regular Session.

**LD 1072**    **An Act Regarding Survivor Benefits in the Event of Divorce and Remarriage**

**SUMMARY**

Under current law, when a retiree divorces, the retiree is unable to remove the divorced spouse as the retirement survivor beneficiary. This bill allows a retiree to change beneficiaries with the agreement of the original spouse, either as part of a divorce agreement or at a later time.

Committee Amendment "A" (S-161) requires the Executive Director of the Maine State Retirement System to ensure that a spouse is counseled by an employee of the retirement system prior to agreeing to give up the right to a retirement benefit. The amendment changes the formula for calculation of the new beneficiary's benefit to be actuarially equivalent to the prior benefit. The amendment adds the provisions of the bill to the laws relating to participating local districts. The amendment also adds an emergency preamble and clause and a fiscal note to the bill.

**LD 1125**    **An Act to Amend the Disability Provisions of the Maine State Retirement System Laws**

**SUMMARY**

This bill provides that when disability resulting from a preexisting condition that has been aggravated by an injury or accident received in the line of duty the accident or injury must be outside the usual activities encountered in the member's employment.

Committee Amendment "A" (S-204) adds a fiscal note.
