This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

LD 1110 An Act Regarding Passing of School Buses

**PUBLIC 348
EMERGENCY**

SUMMARY

This bill would have made it illegal for operators of motor vehicles to pass a stopped school bus carrying passengers of all ages. Current laws make it illegal to pass a school bus that is carrying school-aged children. This bill also would have eliminated the definition of school-aged children.

Committee Amendment "A" (H-378) replaces the original bill and clarifies its original intent. This amendment expands the requirement that the lights be activated on a school bus discharging or receiving school-age children to include clients of the Pineland Center regardless of age.

LD 1121 An Act Relating to Transportation Planning **ONTP**

SUMMARY

This bill would have removed the toll from exit 15 and, for southbound traffic, from exit 14 on the Maine Turnpike. The remaining tolls would have been adjusted to maintain an equivalent amount of revenues by the Maine Turnpike Authority. It would have required the Department of Transportation to take into consideration the quality of community life, municipal comprehensive plans and the full range of transportation alternatives when planning highway projects. Additionally, the bill would have established a demonstration project staggering the work hours of state employees in order to relieve traffic congestion in the Augusta area and established a study commission to review the structure and highway planning functions of the Department of Transportation.

LD 1142 An Act to Amend the Laws That Govern Stopping for Certain Approaching Animals **ONTP**

SUMMARY

This bill would have required motor vehicle operators to stop their vehicles when signalled to do so by a person riding, driving or leading a horse or other animal on a public way. This bill would have removed the condition that the animal or horse must appear frightened in order for the motor vehicle operator to stop.
