An Act to Permit Timely Certificate of Need Approval of LD 1132 Hospital Projects Identified as Urgent

SUMMARY

Under existing law, all so-called major hospital projects must be grouped for a one-time annual review within the constraints of the Certificate of Need Development Account. Projects that were identified by the Department of Human Services as "urgent and compelling" for which insufficient funds remain in the account must be deferred for an additional year and again face competitive review. This bill permits those projects that have already been identified as urgent and compelling to be approved immediately upon the recrediting of funds to the Certificate of Need Development Account.

SUMMARY

Effective January 1, 1992, this bill replaces several specific smoking prohibitions with a general ban on smoking in enclosed areas of public places. The bill retains current law with regard to smoking in restaurants and in the workplace.

Committee Amendment "A" repeals the entire bill and substitutes a simpler, narrower proposal that prohibits smoking in enclosed areas of buildings to which members of the public are invited or permitted to be and in rest rooms which are available for public use. Among the exceptions made to the prohibition are taverns and lounges, private offices, small owner-operated stores, beano games and civil auditoriums. Restaurants, hospitals and the work place continue to be governed by their own laws. Those portions of existing law which are duplicative and which would be superfluous if this proposal were enacted, are repealed. Enforcement by the Department of Human Services is removed, leaving to the court system the enforcement of the law. The Department of Human Services is charged with enforcement activities.

SUMMARY

This bill enhances child support collection efforts by directing the Department of Human Services to claim state tax refunds and lottery winnings of persons who owe the State for child support obligations. The bill also authorizes the Department of Human Services to use private collection agencies for the purpose of collecting child support.

Committee Amendment "A" (H-342) clarifies that only liquidated child support debts must be forwarded to the Department of Finance, Bureau of Lottery and the Tri-State Lottery Commission for setoff against lottery winnings and that prior to offset the Bureau of Lottery or the Tri-State Lottery Commission shall provide notice to winners. The amendment eliminates provisions in the bill that allow the Department of Human Services to use private collection agencies to collect child support debts. It also eliminates a redundant section that requires the Department of Human Services to notify the State Tax Assessor of child support debts. A similar provision currently exists in the statutes. The amendment adds an emergency preamble, emergency clause and fiscal note to the bill.
