#### **SUMMARY**

This bill creates an Integrated Pest Management Fund to develop and implement an expanded and improved integrated pest management program. The bill also creates an Integrated Pest Management Advisory Committee to advise the commissioner on the awarding of research and private sector grants and advise the University of Maine Cooperative Extension Service on the development of its plan of work. The bill establishes reporting requirements for grant recipients. The bill directs the Commissioner of Agriculture, Food and Rural Resources to credit funds received from any source for the development and implementation of IPM programs to the IPM Fund. General Fund appropriations are allocated on a percent basis to specific entities and for specific purposes.

Committee Amendment "A" (H-273) adds a 9th member to the Integrated Pest Management Advisory Committee. It mandates that a member of the Board of Pesticides Control be a member of the committee and specifies that the board member must be the person designated in the Board of Pesticides Control laws as a scientist from the University of Maine System specializing in agronomy or entomology having practical experience and knowledge of integrated pest management. In addition, this amendment made stylistic and technical changes to conform to preferred statutory language. The amendment also added an appropriation section and a fiscal note to the bill.

Senate Amendment "B" (S-446) eliminated the appropriations section and changed the fiscal note to indicate that expenses of the Integrated Pest Management Advisory Committee will be absorbed by the Department of Agriculture, Food and Rural Resources.

#### **SUMMARY**

This bill as amended by Committee Amendment "A" (H-270) and House Amendment "A" (H-503) does the following:

- 1. Requires the Department of Agriculture, Food and Rural Resources to investigate all complaints involving farm operations and establishes a procedure for complaint resolution.
- Establishes an Agricultural Complaint Response Fund. The Commissioner of Agriculture, Food and Rural Resources may accept money designated for this fund from any source and may authorize expenditures from the fund to investigate complaints and to abate pollution or nuisance conditions resulting from farm operations.
- 3. Requires municipalities to submit to the Commissioner of Agriculture, Food and Rural Resources a copy of any proposed ordinance that would impact farm operations. The commissioner is directed to review the proposed ordinances and advise the municipality if the proposed ordinance would restrict the use of best management practices.

This original bill proposed the establishment of a Ground Water Contamination Fund to be funded by a fee on the sale of pesticides and fertilizers. Committee Amendment A (H-270) struck the section of the bill that created this fund and established the Agricultural Complaint Response Fund. House Amendment "A" (H-503) clarified language pertaining to review of municipal ordinances and struck language relating to the awarding of costs in nuisance suits.

#### LD 1320 An Act to Revise the Maine Horticultural Laws

#### **SUMMARY**

This bill proposed revision of Maine's horticultural laws, repealing 7 MRSA c. 405 and enacting 7 MRSA c. 405-A. The bill would have done the following:

- replaced the annual inspection requirement for licensed nurseries with inspections at a frequency determined by the State Horticulturist;
- clarified definitions;
- established a procedure to be followed when nurseries are found to be infested with plant pests;
- authorized the Commissioner of Agriculture, Food and Rural Resources to assess fees for the inspection of material other than nursery stock and to implement the provisions of the bill; and
- increased the fee for obtaining a license to sell or deal in nursery stock from \$5 every 3 years to \$20 annually.

Committee Amendment "A" (H-409) restructured provisions of the bill. It reduced the penalty for violations of horticulture laws from not less than \$500 to not more than \$500 and added a fiscal note to the bill.

House Amendment "A" (H-414) established a 2-tier license fee schedule with a fee of \$5 annually for applicants with annual gross receipts of less than \$2,500 and a license fee of \$20 annually for all others.
