This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

**SUMMARY**

In 1986, the voters approved a bond for the construction of a maximum security facility in Warren, Maine. Construction has begun and the facility is expected to be ready in 1992. This bill establishes in statute the Maine Correctional Institution -- Warren as a separate administrative entity. Because of collective bargaining agreements, doing so (rather than running it as part of the Maine State Prison) affects how guards are hired and assigned at the new facility. The bill is being carried over the Second Regular Session to allow the Department of Corrections to negotiate with its unions.

**SUMMARY**

This bill transfers jurisdiction over county jails, including their facilities, debts and obligations, from the counties to the Department of Corrections. The bill has been carried over to the Second Regular Session.
