This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

SUMMARY

This is one of 8 bills containing the recommendations of the Commission on Maine's Future. This resolve would have established the Task Force on Life-long Learning and Educational Choice. The task force would have studied teacher training, curriculum development and facilities planning and propose a comprehensive integration of the various parts of our educational system and the means of meeting the life-long learning opportunities in the State.

LD 1571 An Act Relating to Level I and Level II Educational Technicians

SUMMARY

This bill grandparents former teacher aides and assistants as level II or level III Educational Technicians in the school district in which they are employed without requiring them to meet the current certification requirements for Ed Tech II or III. The bill further provides that former teacher aides do not become members of the Maine State Retirement System when hired as Ed Tech II or III in order to protect their status under Social Security. The membership status of aides who belong to the retirement system due to employment in participating local districts is not affected by this bill.

The Committee Amendment (H-477) replaces the language of the bill with unallocated language clarifying the intent of the bill. The amendment provides that former teacher aides promoted to level II or level III Educational Technicians before September 1, 1991 retain the type of retirement coverage they had prior to promotion. The amendment also waives the professional certification requirements for teacher aides (level I Educational Technicians) and teacher assistants (level II Educational Technicians) promoted before September 1, 1991 to be certified as level II or level III Educational Technicians if they were actually performing the functions of the level II or level III position prior to promotion. The amendment also adds an emergency preamble and emergency clause to the bill.

This bill would have eliminated the statewide educational assessment program.
