All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

SUMMARY

The bill made changes in the Northern Maine Regional Planning Commission and Northern Regional Planning Commission charters. It authorized the merger of the Northern Regional Planning Commission and the Northern Maine Regional Commission under one name, "The Northern Maine Regional Planning Commission, Inc." and broadened the purpose of the commission. The bill also made changes necessary to meet economic development administration guidelines and the guidelines for nonprofit corporations issued by the United States Internal Revenue Service.

The bill made the changes to the executive board which:

- A. Increased the rule making authority of the executive board;
- B. Clarified the residency requirements for unorganized township representatives and it removed the requirement that the chair and vice-chair be elected officials;
- D. Made executive board members responsible for notifying alternate members their attendance is required and authorized the replacement of executive board members who missed 4 consecutive executive board meetings without just cause; and
- E. Allowed the executive director to group communities into several subdistricts and reduced the power given to standing committees.

The bill also:

- A. Changed the planning commission districts to correspond with county commissioner districts in Aroostook County;
- B. Required that the 2 annual overall board meetings must be held in the months of May and November;
- C. Removed charter language that was adequately covered in Public Law 1989, chapter 89, section 10.

Committee Amendment "A" added an emergency preamble and an emergency clause to the bill. It also removed new text from a section of the original Charter for the Northern Regional Planning Commission and the Northern Maine Regional Planning Commission and deleted a subsection of the charter that was redundant.
