This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

**SUMMARY**

This bill makes several changes to the election laws regarding electronic voting machines. The bill requires the Secretary of State to provide test ballots, permits municipal clerks to open a packet of test ballots to test electronic voting systems, and establishes procedures governing the clerk's handling of test ballots.

The bill requires the Secretary of State and the Attorney General to jointly establish rules to govern approval of voting machines and electronic voting systems and clarifies that the Secretary of State has the authority to establish rules to recommend certain approved machines or systems to minimize the cost of producing ballot materials. The bill also amends the definition for electronic voting system to include both punch card and mark-sense systems, defines those systems, and clarifies which provisions of law apply to each system.

Committee Amendment "A" (H-397) adds a fiscal note to the bill.
