All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

#### **SUMMARY**

The original bill provided funding for a number of science and technology related economic development activities, including expanded funding for the Centers for Innovation and the Research and Productivity Center, greater support for the Research Vessel Argo-Maine, and expansion of the state match to federal grants from the National Science Foundation, NASA and other federal programs.

Committee Amendment "A" (H-657) made a computation correction to the appropriation section of the bill and added a fiscal note.

Senate Amendment "A" (S-433) deleted Committee Amendment "A" and removed the appropriation section from the original bill.

### **SUMMARY**

The original bill required that 15% of the federal funds received by the Division of Community Services under the Low-income Home Energy Assistance Program, or LIHEAP, be transferred to the Maine State Housing Authority because the authority is now responsible for the administration of energy conservation programs formerly administered by the division. The bill required that the amount transferred be prorated from April 1, 1991 to the end of fiscal year 1990-91. The bill also clarified that those funds must be used for weatherization, weatherization-related repairs, rehabilitation technicians, heating system improvements and mobile home rehabilitation.

Committee Amendment "A" (H-652) amended a fiscal note to the bill.

Senate Amendment "B" (S-362) to Committee Amendment "A" deleted the provision of the original bill that transferred Low-income Home Energy Assistance Program funds from the Division of Community Services to the Maine State Housing Authority and replaced it with more comprehensive details concerning the transfer. The amendment made clear that not less than 15% of the Low-Income Home Energy Assistance Program funds must be transferred to the authority for energy conservation assistance programs. The amendment also clarified that the division must transfer to the authority the balance of all remaining funds allocated to energy conservation programs for the program year 1990-91.

House Amendment "A" (H-707) struck the emergency preamble and emergency clause from the bill. It also added a fiscal note to the bill that was inadvertently removed by Senate Amendment "B" to Committee Amendment "A".
