This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

All adopted amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor for floor amendments. Final action on each bill is listed to the far right of the title. Various types of final action are abbreviated as follows:

PUBLIC XXX	Chapter # of enacted Public Law
P&S XXX	Chapter # of enacted Private & Special Law
RESOLVE XXX	Chapter # of enacted Resolve
CON RES XXX	Chapter # of Constitutional Resolution passed by both Houses
EMERGENCY	Enacted law takes effect sooner than 90 days
CARRIED OVER	Bill carried over to Special Session
ONTP	Ought Not to Pass report accepted
LVWD	Leave to Withdraw report accepted
INDEF PP	Bill Indefinitely Postponed
FAILED EMERGENCY ENACTMENT	Emergency bill failed to get 2/3 vote
DIED BETWEEN BODIES	House and Senate disagree; bill died
CONF CMTE UNABLE TO AGREE	Committee of Conference formed but unable to agree
VETO SUSTAINED	Legislature filed to override Governor's Veto
UNSIGNED	Not signed by Governor within 10 days
DIED ON ADJOURNMENT	Action incomplete when session ended; bill died

SUMMARY

This resolution proposed a change to the Constitution of Maine to allow the first deputy secretary of state to act as Secretary of State and the deputy treasurer of State to act as Treasurer of State until the Legislature elected a new Secretary of State and a new Treasurer of State, respectively.

Committee amendment A (H-932) clarified the provisions of the bill by indicating the process for selection of a successor to the Secretary of State and the Treasurer of State if a vacancy occurs while the Legislature is in session. The amendment also added a fiscal note.

House amendment A (H-1032) clarified the wording in the committee amendment.

AMENDMENTS ADOPTED

SUMMARY

This bill would have organized the Bureau of Alcoholic Beverages into 2 functional sections: licensing and merchandising. The bill would also have added two Licensing Agents to the Bureau and eliminated the Deputy Director, Retail Store Operations Director, a Clerk Typist III, the Carpenter Foreman and 3 Retail Store Supervisors. The Legal Affairs Committee considered the bill and after a straw vote recommending that the bill ought not to be passed, voted to rerefer the bill to the State and Local Government Committee.

The majority of the State and Local Government Committee voted that the bill ought to pass as amended by Committee Amendment A (H-1194). Committee Amendment "A" would have restored the positions of Deputy Director and Clerk Typist III, and changed the wording of the bill to coordinate the language with language that was likely to be adopted in the budget bill.
