### An Act to Amend the Laws Governing the State Claims Commission

#### SUMMARY

This bill requires the appraiser members of the State Claims Commission to be certified general appraisers. The bill also simplifies the process for appeals from decisions of the commission and other administrative processes of the commission. .

Committee Amendment "A" (H-942) reduces the time the Department of Transportation has to pay an award issued by the State Claims Commission to the owner of condemned property. The bill proposed the payment be made within 90 days; the amendment requires payment to be made within 60 days. The amendment also strikes a section of the bill concerning the calculation of interest payable on an award issued by the commission leaving existing law in place. Currently, interest is payable from the date of taking of the property to the date the commission issues its award. The amendment also adds a fiscal note to the bill.

### **SUMMARY**

This bill provides that the time and temperature sign in Portland is not subject to the Maine traveler information services laws (Billboard Law).

Committee Amendment "A" (H-951) clarifies the conditions under which the time and temperature sign in Portland may be operated under an exemption from the Maine traveler information services law. Under the terms of the amendment, the sign may not be enlarged and is limited to the use of 2 words or groupings of characters not exceeding 4 letters or characters each which are displayed for 4 seconds each.
