SUMMARY

The original bill changes the name of "high school equivalency certificates" to "high school equivalency diplomas" to be consistent with federal laws.

Committee Amendment "A" (S-539) retains that change, restructures the statute to clarify the requirements for granting a diploma to persons who are 17 or 18 years of age, removes the Maine residency requirement for eligibility, permits assessment of a fee to out-of-state applicants and adds a fiscal note.

SUMMARY

Current law allows Husson College to grant specific bachelor of science degrees. The original bill allows Husson College to grant any bachelor of science degree.

The original bill also consolidates all the existing legislation conferring authority to Husson College to grant specific degrees: the authority to confer bachelor degrees derived from the original act, Private and Special Law 1953, chapter 11, as amended by Private and Special Law 1963, chapter 15 and Private and Special Law 1981, chapter 105 which authorized a degree of bachelor of science in nursing; the authority to confer associate degrees derived from Private and Special Law 1965, chapter 121 and Private and Special Law 1969, chapter 213; the authority to confer master degrees derived from Private and Special Law 1977, chapter 13; and the authority to confer honorary doctorate degrees derived from Private and Special Law 1969, chapter 90.

Committee Amendment "A" (S-565) corrects 2 improper references in the original bill that would have limited the authority of Husson College to grant bachelor of science degrees and associate science degrees.

Committee Amendment "A" (S-564) corrects a reference in the original bill and adds a fiscal note.
