#### **SUMMARY**

This bill enacts two provisions originally contained in the majority Committee Amendment to LD 2008. It was enacted without reference to Committee.

Section 1 permits the Maine State Retirement System to collect from the employer any additional actuarial and administrative costs that result from an employer's improper application of retirement statutes and rules, provision of misinformation or omission of information.

Section 2 ensures that the position of advocate at the Maine State Prison continues to be under the special retirement plan that covers employees of the Maine State Prison.
