This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

The committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

An Act to Retain the Current Standard for the Release of Tributyltin in Marine Antifouling Paints

SUMMARY

The intent of this bill was to repeal an increase in the restriction on the release of tributyltin from antifouling marine paints.

Committee amendment "A" (H-32) was necessary to correct drafting errors in the bill. The amendment repeals the increase in the restriction on the release of tributyltin from antifouling marine paints that took effect on September 1, 1992. Repeal of that provision establishes a lawful tributyltin release rate equal to or less than 4.0 micrograms per square centimeter per day. The amendment makes that repeal retroactive to September 1, 1992.

SUMMARY

This bill would have required the Commissioner of Marine Resources to notify a municipality of the opening of closed coastal water or intertidal zone area within that municipality's borders.

Committee amendment "A" (H-41) replaced the bill. This amendment requires the Commissioner of Marine Resources or the commissioner's authorized designee to give oral notice to local governmental authorities upon signing an emergency rule that opens an area or waters to the taking of marine organisms. Existing law requires notification only when the commissioner adopts an emergency rule that prevents the taking of polluted or contaminated marine organisms.

House amendment "A" (H-48) is a technical amendment presented on behalf of the Committee on Bills in Second Reading that adds an emergency clause to the committee amendment.

LD 33 An Act to Establish a Date for Removal of Fishing Shacks from Tidal Waters
