# JULY 1993

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

The committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

### **SUMMARY**

This bill allows a minor to remain in a lounge until 8:00 p.m. even though the minor is not accompanied by a parent, legal guardian or custodian.

Senate Amendment "A" (S-28) would have given municipalities the option to let a minor remain in a lounge after 8:00 p.m.

Senate Amendment "B" (S-38) would have prohibited a minor from remaining in a lounge after 2:00 p.m. if the minor was not accompanied by a parent, legal guardian or custodian.

## **SUMMARY**

This bill prohibits the racing of greyhounds for public exhibition.

Committee Amendment "A" (S-43), the majority committee report, prohibits the racing of greyhounds for public exhibition and prohibits the transmitting or receiving of interstate simulcasting of greyhound racing for commercial purposes. The amendment requires that a person who violates this new chapter be subject to a civil penalty of not less than \$7,500, payable to the state. The amendment also adds a fiscal note.

This bill would have granted the Saco River Corridor Commission authority to regulate the use of alcohol on land and water within the corridor. It would have granted the commission authority to adopt rules to regulate that behavior, provide that the rules preempt municipal ordinances related to alcohol use and specifically authorize municipal law enforcement officials to enforce those rules.

### **SUMMARY**

This resolve would have required the State to compensate property and business owners around Sebago Lake for damages incurred as a result of the lowering of the water level from the 1990 water level. The resolve states that the State does not have direct authority over the water level in Sebago Lake, but did work with the owners of the hydroelectric plant that affects the lake level and with other interested parties to establish a water level that resulted in the water being lower in 1991 and 1992 than it had been in the previous years.
