This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

The committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

SUMMARY

This bill proposed to require the Commissioner of Inland Fisheries and Wildlife, upon receipt of an application, to designate the owner of a sporting goods store as an agent of the department for the purpose of operating the store as a bear, deer or moose registration station if the store has an inventory of hunting and fishing supplies with a value of \$10,000 or more. It also would have required the commissioner to refuse designation when the owner of a store has been convicted of a crime that is punishable by a jail sentence of one year or more or when the commissioner finds a reasonable basis for denial.
