This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

The committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

LD 785	Resolve, Directing the Office of Waste Reduction and
	Recycling to Study the Recycling of Incinerator Ash

SUMMARY

This resolve would have required the Maine Waste Management Agency, Office of Waste Reduction and Recycling to conduct a study of innovative technologies for the recycling and reuse of incinerator ash.

LD 796 An Act Regarding the Motor Vehicle Emission Inspection CARRIED OVER Program

SPONSOR(S) COMMITTEE REPORT AMENDMENTS ADOPTED

SUMMARY

This bill requires a contractor operating a public emissions inspection station to issue a notice for a motor vehicle that fails to meet public emission standards. The notice must state the cause of failure and the repairs necessary to bring the vehicle into emission standards compliance. The bill also makes a certificate of compliance valid for 2 years from the date of issuance.

The bill was carried over to the Second Regular Session.

SUMMARY

The bill would have reduced the annual fee under the toxics reduction program for facilities that generate less than 100 kilograms of hazardous waste in a calendar month from \$100 to \$50.

SUMMARY

This resolve would have required the Department of Environmental Protection prepare to prepare a report on the feasibility of the State assuming permitting authority over federal wetlands.

Committee amendment "A" (H-272) replaced the bill. The amendment requires the Department of Environmental Protection to work in cooperation with the State Planning Office in the preparation of a report on the feasibility of the State assuming permitting authority over federal wetlands and methods for the State to reduce duplication in wetland permitting.

The amendment also creates a one-year project position at the State Planning Office, funded by federal grant monies, for the purposes of providing staff support for the project. The requirements of this resolve are in effect only if that grant is received and the project position is established.
