This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

The committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number, together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

#### **SUMMARY**

This bill changes the required number of county commissioners in Cumberland County from 3 to 9. The Cumberland County voters will elect the required 9 county commissioners according to the reapportioned districts in the fall of 1994 and the newly elected commissioners will take office on January 1, 1995. The bill also sets the salary for the first fiscal year at \$2,000 for each commissioner.

#### **SUMMARY**

This resolution calls a constitutional convention for the purpose of proposing amendments to the Constitution of Maine. The resolution calls for a convention to be composed of 2 delegates from each House District to begin on the first Tuesday of September, 1993. Primary elections, if any, will occur on the first Tuesday of July, 1993 and election of delegates will take place on the first Tuesday of August, 1993. Recommended changes would be voted on at the statewide election in November, 1993.
