This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

The committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

SUMMARY

Under current law, a retail licensee can not employ a person as a retail employee if the person in the past 5 years has been convicted of violating the laws prohibiting the illegal sale of liquor or allowing the consumption of liquor by certain persons. This bill changes the waiting period for such employment from 5 years to 2 years.

Committee Amendment "A" (H-256) clarifies that a person convicted of a first offense of violating the laws prohibiting the illegal sale of liquor or allowing the consumption of liquor by certain persons must wait 2 years before that person may be employed as a retail employee. A person convicted of a 2nd offense of violating the laws prohibiting the illegal sale of liquor or allowing the consumption of liquor by certain persons must wait 5 years before that person may be employed as a retail employee.

This bill would eliminate seasonal state and agency liquor stores. Transition provisions would allow seasonal liquor stores existing in 1992 or 1993 to convert to year-round operation.

SUMMARY

This bill would have authorized the State Harness Racing Commission to regulate coin-operated electronic video credit machines that award credits redeemable for cash. Machines would have been placed in establishments at pari-mutuel tracks and would have accepted coins or bills, with a maximum play of \$2 per game. Maximum payoff would have been \$1,000. Machines would have been required to pay out in

credits at least 80% of the total amount played and approved games would have included poker, keno and blackjack.

Machines would have been linked by telephone line to a central computer of the State Harness Racing Commission for reporting revenue, other data and malfunctions.

The Treasurer of State would have received a share of the net income from the machines after payout of prizes. The State's share would have begun at 15% and increased to 20%. Twenty-five percent of the state money would have been used to increase the funds available for municipal revenue sharing.

Manufacturers and operators of the machines would have been required to be licensed by the State Harness Racing Commission. Applicants for licenses would have been subject to background investigations.
