**LD 1117**      **An Act to Improve the Functions and Operations of the Maine State Retirement System**

**AMENDMENTS ADOPTED**

**SUMMARY**

This bill makes the Maine State Retirement System as a public instrumentality of the State. The bill puts authority and responsibility for personnel functions under the board of trustees, subjects the Maine State Retirement System to the Municipal Public Employees Labor Relations Law and provides for a two year transition period in which employees retain all their rights as state employees. The bill provides for a review of the system's administrative budget prior to the beginning of each fiscal year by the legislative committee having jurisdiction over retirement matters.

The provisions of this bill were enacted through various sections in Public Law 1993, c. 410, Part L.

**LD 1245**      **An Act Related to Disability Retirement under the Maine State Retirement System**

**AMENDMENTS ADOPTED**

**SUMMARY**

This bill would have amended the legislative disability retirement provisions to put Legislators under the same disability plan as state employees. The bill also would have amended the disability plans of the Maine State Retirement System to provide that a member would not be eligible for disability retirement benefits based on a disability that arises in connection with commission of a crime or results in conduct of which the consequence is conviction for a crime. A person would not be entitled to any disability benefits for any period of incarceration over 30 days, service credit could not accrue during incarceration, and incarceration could not delay the time period for disability review. The bill also would have allowed a disability benefits to be discontinued upon the final administrative decision to discontinue even if a judicial appeal is being pursued.

**LD 1308**      **An Act to Provide Equitable Representation on the Board of Trustees of the Maine State Retirement System**

**AMENDMENTS ADOPTED**

**SUMMARY**

This bill would have added 2 members to the Board of Trustees of the Maine State Retirement System, one who is a member of the retirement system through employment as a participating local district employee and who is appointed by the AFL-CIO and one member of the retirement system appointed by the Maine School Management Association. The bill also would have increased the number of members needed for a quorum from 4 to 6 and the minimum number of votes needed to take action from 4 to 6.
