This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

The committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

<i>VETO SUSTAINED</i>	<i>Legislature failed to override Governor's Veto</i>
<i>UNSIGNED</i>	<i>Not signed by Governor within 10 days</i>
<i>DIED ON ADJOURNMENT</i>	<i>Action incomplete when session ended; bill died</i>

This bill proposed to allow landowners to receive permits to take any deer on that landowner's property during open season on deer.

**LD 1165**      **An Act Regarding Hunting of Deer with Muzzle Loaders**      ONTP

**SUMMARY**

This bill proposed to allow hunters who hunt during the special muzzle-loading open season to take any deer, regardless of its sex, during the special muzzle-loading open season.

**LD 1171**      **An Act to Amend the Hunting Laws**      ONTP

**SUMMARY**

This bill proposed to prohibit anyone, including the owner of the land, from hunting on land that has been posted with "no hunting" signs.
