This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

The committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

An Act to Amend the Law Regarding Rate Setting at Residential Treatment Centers

SUMMARY

This bill amends the law that specifies that the annual inflation rate to be used to increase or decrease rates in residential child care facilities when rates have not been set by July 1st of each year be changed from that published by Data Resources, Inc., which is obtained through payment of a subscription, to the Consumer Price Index for all Urban Consumers, which is obtained at no cost.

This bill requires that a death certificate be filed no more than 14 days after death occurred.

LD 1150 An Act to Promote Electronic Transfer of Funds and Other Information System Improvements in State Government

SUMMARY

This bill amends a section of the Maine Revised Statutes regarding disbursements of state funds to allow broader use of electronic transfers of funds and requires that electronic transfers of funds be expanded in the State's cash assistance programs and for state retirement benefits. The bill also directs the Department of Human Services to take advantage of federal matching funds to improve automation of Medicaid claims and eligibility functions in income maintenance programs.

Amendment H-512 gives more time to the Department of Human Services to implement the electronic transfer of funds and the "one-stop-shopping" eligibility system required by the bill. It also adds a fiscal note to the bill.

SUMMARY

This resolve requires the Department of Human Services to develop a plan for assisted living facilities for use by low-income people. This resolve directs the department to pursue Medicaid waivers for assisted living facilities and to develop programs to serve individuals with Alzheimer's disease and

other dementia illnesses. The resolve also establishes a moratorium on the licensing of additional nursing home beds until the department develops and implements the plans required by this resolve.

SUMMARY

This bill authorizes Maine Emergency Medical Services to develop and coordinate a statewide system of emergency care to treat seriously injured patients, including coordination of the roles of hospital and prehospital providers through a system plan, rules and protocols.

Amendment H-386 removes the authorization for Maine Emergency Medical Services to implement a trauma care system in the State. This amendment only authorizes the plan to be developed and directs Maine Emergency Management Services to submit the plan and implementing legislation to the Legislature by January 1, 1994. The amendment also adds a fiscal note to the bill.

Amendment H-438 clarifies that the Emergency Medical Services' Board appoints the members of the State Trauma Prevention and Control Advisory Committee.

This bill allows community health centers to qualify for loans through the bonding authority of the Maine Health and Higher Educational Facilities Authority Act.

Amendment H-561 makes technical corrections to resolve internal inconsistencies in the terms used to describe eligible organizations.

SUMMARY

Current law provides for an initial application fee of \$10 and a \$20 biennial reapplication fee for licensure as either a day care facility, nursery school or registered home baby-sitting service. This bill removes the amount of these fees from the law and requires the department to establish the amount of the fees by rule.
