SUMMARY

This bill was part of the 1992 recommendations of the Special Commission on Governmental Restructuring. The bill changes the selection process so that the State Auditor is nominated by the Governor and confirmed by the Legislature and directs the Department of Audit to conduct management performance audits in addition to financial audits. The bill also changes the name of the Joint Standing Committee on Audit and Program Review to the Joint Standing Committee on Audit and Management Review and focuses its work on management reviews based upon the State Auditor's work and program and management review assignments from the Legislative Council.

This constitutional resolution provides for citizen recall of elected officials for misfeasance, malfeasance or violation of oath while in office on the petition of qualified voters equal to 35% of the total number of votes cast for that office in the preceding election. If enough valid signatures are received, an election must be held to vote on the recall. The ballot contains a statement of the reason for the recall and a statement of justification by the officer.

COMMITTEE AMENDMENT "A" (H-852) replaces the bill and establishes the Somerset County Budget Committee consisting of 2 municipal officers and 1 municipal official from each county commissioner district as voting members and 3 nonvoting members of the county legislative delegation. Voting members serve 3-year
