SUMMARY

This bill requires that a visitor, guardian ad litem or attorney be appointed for the person alleged to be incapacitated in every guardianship or conservatorship proceeding. The bill also provides for increased notice and opportunities for challenge to an action for appointment of a temporary guardian or conservator.

COMMITTEE AMENDMENT "A" (H-937) corrects the title of the bill and adds a fiscal note and cross-reference changes.

SUMMARY

This bill would have provided, under the Maine Tort Claims Act, that governmental entities are not required to defend or indemnify an employee for a claim that arises from the use of a vehicle not owned or leased by the governmental entity.

A similar provision was included in the budget bill imposing liability on an employee of a governmental entity or the owner of a vehicle used for governmental purposes if there is insurance that provides primary coverage. See Public Law 1993, chapter 707, section G-8.

SUMMARY

This bill allows certain persons pardoned by the Governor to apply to the State Bureau of Identification after 10 years and if the person has not been convicted of another crime to arrange to have references to the pardoned crime deleted from the Federal Bureau of Identification's identification record.

COMMITTEE AMENDMENT "A" (S-496) adds an emergency clause and preamble and a fiscal note.
