**SUMMARY OF LEGISLATION BEFORE
THE JOINT STANDING COMMITTEES**

AUGUST 1995

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries. The publication, History and Final Disposition of Legislative Documents, is helpful in determining to which committee any particular bill was referred.

In this document, the committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number, together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various categories of final action are abbreviated as follows:

CARRIED OVER	<i>Bill carried over to Second Session</i>
CON RES XXX	<i>Chapter # of Constitutional Resolution passed by both Houses</i>
CONF CMTE UNABLE TO AGREE	<i>Committee of Conference unable to agree; bill died</i>

LD 59 An Act to Repeal the Sensible Transportation Policy Act

The bill proposes to repeal the Sensible Transportation Policy Act. The Sensible Transportation Policy Act requires the Department of Transportation, when making planning, capital investment and project decisions, to consider and comply with certain environmental and policy considerations and to establish a procedure for public participation.

LD 72 An Act to Require Safety Seat Belts in New School Buses

SUMMARY

Under current law, the initial license fee for an official business directional sign may not exceed \$30, and the annual renewal fee may not exceed \$30. This bill would have reduced both those fees to an amount not to exceed \$10.

This bill would have required that contributions to the Maine Environmental Trust Fund received from the renewal of environmental registration plates remain in the fund for the use of the Department of Conservation and the Department of Inland Fisheries and Wildlife and that no portion of these contributions be transferred to the Secretary of State.
