SUMMARY OF LEGISLATION BEFORE THE JOINT STANDING COMMITTEES

AUGUST 1995

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries. The publication, <u>History and Final Disposition of Legislative Documents</u>, is helpful in determining to which committee any particular bill was referred.

In this document, the committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number, together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various categories of final action are abbreviated as follows:

LD 205 An Act to Amend Provisions of Law Voiding a Lease for Premises Defined as a Common Nuisance

SUMMARY

This bill repealed the provision of law that authorized the voiding of a lease for premises that constitute a common nuisance.

COMMITTEE AMENDMENT "A" (H-127) repealed Title 17, section 2744 and shifted the burden to a landowner to demonstrate that a nuisance has abated before any injunction or order may be modified or lifted in keeping with the common law procedure for determining the duration of when a nuisance injunction runs with the land. This amendment also prohibited a landlord from voiding the lease of a tenant on the grounds that the tenant had caused a common nuisance unless a declaration of a common nuisance was made by the Superior Court, upon the filing of information in the Superior Court pursuant to Title 17, section 2741 or upon a similar finding by the District Court as part of a forcible entry and detainer action commenced under Title 14, chapter 709. It also added a fiscal note to the bill.

SUMMARY

This bill would have amended the law regarding the eviction of mobile home park tenants by changing the "liquidated damages" language to a late fee.

SUMMARY

This bill would have required landlords to pay tenants interest earned on security deposits held in escrow accounts, subject to the conditions of the return of the security deposits. The bill would have required landlords to pay the interest accrued to that portion of the security deposit being returned to a tenant. This change would have applied to any security deposits held in an escrow account on January 1, 1996 and to any deposits placed in an escrow account after that date.

This bill clarified the difference between a Class A restaurant and a Class A restaurant/lounge. It distinguished a Class A restaurant/lounge as an eating establishment that makes 55% or more of its gross
