SUMMARY OF LEGISLATION BEFORE THE JOINT STANDING COMMITTEES

AUGUST 1995

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries. The publication, <u>History and Final Disposition of Legislative Documents</u>, is helpful in determining to which committee any particular bill was referred.

In this document, the committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number, together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various categories of final action are abbreviated as follows:

LD 196 An Act to Develop the Landowner Relations Program

SUMMARY

The bill would have established a funding mechanism for the Landowner Relations Program by requiring hunters, anglers and trappers to purchase a landowner relations stamp. Proceeds from the sale of this stamp were proposed to go to a Landowner Relations Fund.

COMMITTEE AMENDMENT "A" (H-444) replaces the bill. The amendment repeals the supersport combination hunting license and replaces it with provisions that allow a person to purchase a supersport hunting, fishing or trapping license for a \$15 fee paid in addition to the regular license fee. The amendment requires that the Commissioner of Inland Fisheries and Wildlife use 80% of those new fees for a Support Landowners Program targeted to improving landowner relations. The commissioner must use the remaining 20% of the revenues for the Sport Hunter Program targeted at combatting disrespect and misconduct and to improve the image of hunters. The amendment also adds an allocation section and a fiscal note to the bill.

LD 219 An Act to Allow Maine Residents over 70 Years of Age to Hunt ONTP Antlerless Deer

SUMMARY

This bill would have allowed residents over 70 years of age to hunt antlerless deer without a permit.

LD 226	An Act to Strengthen the Laws Pertaining to Poaching	PUBLIC 346

SUMMARY

This bill would have increased the term of mandatory license revocation for a person convicted of any of the following fish and wildlife violations: hunting deer, bear or moose during closed season; night hunting; possession of wild animals or wild birds taken during night hunting; hunting deer after having killed one; hunting or trapping bear after having killed one; exceeding the bag limit on deer or bear; or illegal hunting or possession of moose.

The bill also would have required the Commissioner of Inland Fisheries and Wildlife to notify the United States Fish and Wildlife Service and fish and wildlife officials of all adjacent states and Canadian provinces of any person whose Maine hunting and fishing licenses or Department of Inland Fisheries and Wildlife licenses are revoked for life.

COMMITTEE AMENDMENT "A" (H-458) replaces the bill. The amendment makes mandatory suspensions of licenses issued by the Department of Inland Fisheries and Wildlife for poaching violations effective upon conviction and nonmandatory suspensions for other types of poaching violations effective upon notification by the Commissioner of Inland Fisheries and Wildlife. The amendment retains the minimum periods of mandatory suspension in current law but broadens the commissioner's authority to set the term for other suspensions. The amendment clarifies the hearing process available to a person whose license has been suspended.

2 Inland Fisheries & Wildlife-

The amendment allows the commissioner to dispose of weapons used in poaching violations after conviction without going through the libel process.

The amendment applies to poaching violations that occur after the effective date of the bill.

The amendment also adds a fiscal note to the bill.

LD 244 An Act to Restrict the Use of Motorboats and Personal Watercraft on Certain Bodies of Water

This bill would have required the Commissioner of Inland Fisheries and Wildlife to set aside 50 moose hunting permits for former prisoners of war.
