SUMMARY OF LEGISLATION BEFORE THE JOINT STANDING COMMITTEES

AUGUST 1995

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries. The publication, <u>History and Final Disposition of Legislative Documents</u>, is helpful in determining to which committee any particular bill was referred.

In this document, the committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number, together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various categories of final action are abbreviated as follows:

revenue from the sale of alcohol. The bill also clarified the circumstances under which minors may patronize Class A restaurant/lounges. Before this bill passed, minors and adults under the legal drinking age could not take a meal in eating establishments serving liquor and a light meal or "pub style" menu after 9 p.m.

COMMITTEE AMENDMENT "A" (S-121) replaced the bill and permitted all liquor licensees to begin selling alcoholic beverages at 9 a.m. on Sunday mornings. Under existing law as amended by Public Law 1995, chapter 46 (See LD 32), alcohol could not be sold until noon on Sundays, except by a Class A restaurant or a Class A restaurant/lounge, which may sell liquor on Sunday beginning at 9:00 a.m. The amendment also added a fiscal note to the bill.

SUMMARY

This bill would have prohibited voter registration on election day.

LD 240 An Act to Require Reporting by Political Action Committees ONTP That Endorse or Provide Funds to Local Municipal Candidates

SUMMARY

This bill would have required political action committees that accept contributions, incur obligations or make expenditures in elections for municipal office to register and report to the municipal clerk. Under existing law only municipal candidates must file campaign reports.

The committee voted unanimously to replace the bill with a committee amendment. Later in the session, but before the LD went to the floor, the committee voted to ONTP this bill and folded this amendment into LD 1444, to avoid enacting conflicting law.

SUMMARY

This bill would have amended the statute to include an advance rent payment as part of the tenant's security deposit. The collection of advance rent is limited to 2 months' rent by current law, which limits the amount of security deposit collected to 2 months' rent. Advance rent would not have included rent collected for the next upcoming rental period, and a landlord could not consider the rental period to be longer than one month.

COMMITTEE AMENDMENT "A" (H-129) would have specified that advance rent paid would not be considered a security deposit in 2 situations: when the tenant has voluntarily paid the rent in advance and when the property is a seasonal rental being rented for no more than 4 months. The amendment would have permitted landlords to collect rent in advance in these 2 situations and to not have to escrow those funds with security deposits.

LD 257 An Act to Give Qualifying Status to Certain New Political ONTP Parties for 4 Years

SUMMARY

This bill would have allowed a party that meets these qualifications to participate in all primary and general elections held over the next 4 years without having to requalify after every election.

An amendment suggested to this bill, which was not accepted by the committee, eventually became a minority OTP-AM report to LD 499, An Act Establishing Procedures for New Political Parties to Participate in Primary Elections.

SUMMARY

This bill made it lawful for a person to give and for certain government officials to receive a gift of a subscription to a newspaper, news magazine or other news publication without violating legislative ethics or criminal laws.

LD 293 An Act to Limit Contributions from a Political Action ONTP Committee to \$1,000 in Any Election

SUMMARY

This bill would have decreased the amount of political action committee contributions from a maximum of \$5,000 to a maximum of \$1,000. See LD 443, An Act to Reform Campaign Finance, which the committee passed as its campaign finance bill.
