**SUMMARY OF LEGISLATION BEFORE
THE JOINT STANDING COMMITTEES**

AUGUST 1995

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries. The publication, History and Final Disposition of Legislative Documents, is helpful in determining to which committee any particular bill was referred.

In this document, the committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number, together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various categories of final action are abbreviated as follows:

LD 194 **An Act to Extend the Probationary Period of New Teachers from 2 Years to 3 Years** ONTP

SUMMARY

This bill extends the probationary period of a new teacher from 2 years to 3 years.

SUMMARY

This resolve continues the work of the Commission to Study the Feasibility of a Capital Cultural Center and renames the commission to the Commission to Study the Feasibility of a Telecommunications Center. This resolve requires another report from the commission by November 1, 1995, and authorizes the commission to submit enacting legislation. Funds appropriated from the General Fund are contingent upon receipt by the commission of funds from the City of Augusta and the University of Maine System.

COMMITTEE AMENDMENT "A" (H-21) removes the appropriation section that was inadvertently included in the bill.

LD 263 **An Act to Permit Law Enforcement Officers to Transport Truants Back to School** PUBLIC 124

SUMMARY

Currently, law enforcement officers who see identified truants off school grounds during school hours may not take action except to notify the school or designated school personnel. This bill permits an officer to transport the truant student to the appropriate school.

COMMITTEE AMENDMENT "A" (H-114) replaces the bill. This amendment replaces the requirement that school boards notify local law enforcement officers when a student is habitually truant with a provision that permits school boards to notify officers. The amendment adds a provision that permits an officer to offer to transport a truant to the appropriate school provided the truant and the truant's parent or guardian grant verbal permission.
