#### SUMMARY OF LEGISLATION BEFORE THE JOINT STANDING COMMITTEES

#### AUGUST 1995

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries. The publication, <u>History and Final Disposition of Legislative Documents</u>, is helpful in determining to which committee any particular bill was referred.

In this document, the committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number, together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various categories of final action are abbreviated as follows:

#### **SUMMARY**

This bill encourages local school units to enter into collaborative ventures to pursue the sharing of resources by making such collaborative ventures eligible for the innovative grants program.

COMMITTEE AMENDMENT "A" (H-110) adds 3 provisions to the bill:

1. It requires that each school administrative unit participating in a collaborative venture and receiving an innovative grant agree in writing to the terms of the grant;

- 2. It requires that each group of school administrative units receiving an innovative grant designate one unit as the fiscal agent for the grant; and
- 3. It prohibits a school administrative unit acting separately or as part of a group from receiving more than one innovative grant at a time.

#### **SUMMARY**

This bill adds an additional category to the existing grounds upon which the Commissioner of Education, following review by an appeals committee, may waive teacher certification standards. The bill permits a waiver from the requirement that a teacher must pass the teacher qualifying examination in order to be certified if the teacher demonstrates that the failure to pass is caused by the existence of a learning disability.

#### SUMMARY

This bill amends the laws governing school bus identification to specifically permit a school district to place the district name on the side of the bus.

COMMITTEE AMENDMENT "A" (H-111) replaces the bill. The amendment clarifies that the Commissioner of Education may include specifications concerning school bus identification, including placement of the school district name on the side of a bus, in rules adopted pursuant to the Maine Administrative Procedure Act.
