**SUMMARY OF LEGISLATION BEFORE  
THE JOINT STANDING COMMITTEES**

**AUGUST 1995**

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries. The publication, History and Final Disposition of Legislative Documents, is helpful in determining to which committee any particular bill was referred.

In this document, the committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number, together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various categories of final action are abbreviated as follows:

<i>CON RES XXX</i>	<i>Chapter # of Constitutional Resolution passed by both Houses</i>

**LD 347 An Act to Clarify the Requirements for Truck Widths**

**SUMMARY**

This bill exempts a tarp and tarp hardware used to secure loads on commercial trucks from the width restrictions for trucks.

COMMITTEE AMENDMENT "A" (H-101) expands the original language to include safety devices, other appurtenances and load-induced conditions excluded from width limitations in federal regulations.

**SUMMARY**

This bill would have required the Secretary of State to issue environmental registration plates, commonly known as "loon plates," for a motor home or motorcycle.

**SUMMARY**

This bill would have allowed the Secretary of State to issue vanity plates for commercial motor vehicles. The bill also directed the Secretary of State to determine a design for and issue special amateur radio operator plates.

**LD 375 An Act to Create Special License Plates for Certain Civic Groups**

**SUMMARY**

This bill would have allowed special license plates to be issued bearing the name or insignia of certain civic organizations. The annual fee would have been \$25 with all revenue above the cost of the program allocated to the General Fund.
