**SUMMARY OF LEGISLATION BEFORE  
THE JOINT STANDING COMMITTEES**

**AUGUST 1995**

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries. The publication, History and Final Disposition of Legislative Documents, is helpful in determining to which committee any particular bill was referred.

In this document, the committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number, together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various categories of final action are abbreviated as follows:

**LD 521**      **An Act to Repeal the Laws That Require the Screening for Scoliosis and Related Spinal Abnormalities**      ONTP

**SUMMARY**

This bill repeals the law that establishes in the public schools a screening process for scoliosis and related spinal abnormalities.

**LD 535**      **An Act to Improve the Efficiency of the Maine Technical College System**      ONTP

**SUMMARY**

This bill changes the composition of the Board of Trustees of the Maine Technical College System by requiring certain members to be graduates of the Maine Technical College System and by eliminating 3 ex officio commissioner members. The bill also repeals the requirement that the Maine Technical College System Office provide staff and technical assistance to each college and requires that expenditures for the system office not exceed 2% of the State's appropriation to the system.

**LD 557**      **An Act to Require the Escrowing of the Salary of a School Administrator or Employee Arrested for Certain Crimes**      ONTP

**SUMMARY**

This bill escrows the salary of a school employee charged with sexual abuse or with drug-related crimes. If the employee is convicted of or pleads guilty to the crime charged, the escrowed funds revert to the school administrative unit; otherwise the employee receives the funds.

**SUMMARY**

This bill increases the membership of the Task Force on the Maine School of Visual and Performing Arts enacted by Public Law 1993, chapter 706. This bill provides for the appointment of members from the greater Bangor area and includes the greater Bangor area as a potential site for the school for the arts.
