**SUMMARY OF LEGISLATION BEFORE
THE JOINT STANDING COMMITTEES**

AUGUST 1995

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries. The publication, History and Final Disposition of Legislative Documents, is helpful in determining to which committee any particular bill was referred.

In this document, the committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number, together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various categories of final action are abbreviated as follows:

LD 563 **An Act to Require Local and Employee Participation in the Inspection of the Design of State-funded Buildings** ONTP

SPONSOR(S)	COMMITTEE REPORT	AMENDMENTS ADOPTED

SUMMARY

This bill creates a local review committee that incorporates a public participation process in which local governmental bodies and the public have an opportunity to comment on certain public improvements.

LD 576 **An Act to Facilitate the Use of the Installment Method for the Collection of Sewer Assessments and Charges** PUBLIC 91

SPONSOR(S)	COMMITTEE REPORT	AMENDMENTS ADOPTED

SUMMARY

This bill makes it easier for municipalities to use the installment method for the collection of various sewer assessments and charges by eliminating the requirement that the legislative body first enact an ordinance authorizing the practice. In many towns, it is not practical to call a town meeting prior to the collection of the expenses related to the repair of a malfunctioning septic system or the costs of the construction of a sewer. This bill permits the municipality to provide for the installment method of payment on the order of the municipal officers.

COMMITTEE AMENDMENT "A" (H-83) makes the rate of interest on unpaid assessments and charges the same rate established for delinquent taxes.

LD 590 **An Act to Clarify Law Enforcement Relating to Junkyards and Automobile Graveyards** PUBLIC 58

SPONSOR(S)	COMMITTEE REPORT	AMENDMENTS ADOPTED
KILKELLY	OTP-AM	H-75

SUMMARY

This bill clarifies that municipalities that do not have a local junkyard and automobile graveyard ordinance may enforce the state junkyard and automobile graveyard laws under this enforcement section. It also adds automobile salvage businesses to the list of businesses affected.

COMMITTEE AMENDMENT "A" (H-75) replaces the original bill and removes reference to automobile salvage yards, which are covered elsewhere in the statutes. The amendment also adds automobile recycling businesses for consistency with the Maine Revised Statutes, Title 30-A, chapter 183. The amendment also adds a fiscal note to the bill.

LD 598 **An Act to Establish Landowner Recognition Day** PUBLIC 142

SPONSOR(S)	COMMITTEE REPORT	AMENDMENTS ADOPTED
HALL	OTP-AM	S-66

SUMMARY

This bill establishes the Landowner Recognition Day on the 3rd Saturday in September.

COMMITTEE AMENDMENT "A" (S-66) adds a fiscal note.
