**SUMMARY OF LEGISLATION BEFORE
THE JOINT STANDING COMMITTEES**

AUGUST 1995

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries. The publication, History and Final Disposition of Legislative Documents, is helpful in determining to which committee any particular bill was referred.

In this document, the committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number, together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various categories of final action are abbreviated as follows:

LD 520 An Act to Stop the Alewives Restoration Program in the St. Croix River

SUMMARY

This bill would have prohibited state-funded or state-supported alewife restoration programs on the St. Croix River.

COMMITTEE AMENDMENT "A" (H-78) replaces the original bill. The amendment stops alewife passage through the Grand Falls Dam and the Woodland Dam on the St. Croix River by requiring that the Commissioner of Marine Resources and the Commissioner of Inland Fisheries and Wildlife act to ensure that by May 1st of this year those fishways are configured or operated in a manner that will prevent the passage of alewives. The amendment also changes the bill to an emergency.

LD 524 An Act to Authorize Game Wardens to Enforce Prohibitions against Swimming in Navigable River Channels ONTP

SUMMARY

This bill would have allowed the Commissioner of Inland Fisheries and Wildlife the ability to adopt rules to prohibit swimming in waters that the commissioner determines to be hazardous.

LD 589 An Act to Prohibit Game Wardens from Violating State Laws to Carry Out Their Powers and Duties ONTP

SUMMARY

This bill would have repealed the section of law that allows game wardens, if necessary to carry out their duties, to do "anything otherwise prohibited" by other fish and wildlife laws.

LD 592 An Act to Require a Person to Have a Hunting License to Participate in the Moose Lottery ONTP

SUMMARY

This bill would have amended the moose hunting laws to establish a permit system similar to the system used for antlerless deer permits. Under the system proposed in the bill, a person would have been required to hold a valid hunting license in order to apply for a moose permit.
