**SUMMARY OF LEGISLATION BEFORE  
THE JOINT STANDING COMMITTEES**

**AUGUST 1995**

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries. The publication, History and Final Disposition of Legislative Documents, is helpful in determining to which committee any particular bill was referred.

In this document, the committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number, together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various categories of final action are abbreviated as follows:

**SUMMARY**

This bill proposed to exempt consumer-owned electric utilities from the requirement of getting prior approval of the Public Utilities Commission before entering agreements and contracts relating to generating capacity.

**SUMMARY**

This bill proposed to amend the charter of the Kennebec Water District by increasing the number of members on the board of trustees from 7 to 8 in order to allow the Town of Vassalboro and the Town of Benton to each have a permanent member on the board of trustees.

HOUSE AMENDMENT "A" (H-373), which was developed and approved by the committee, strikes and replaces the bill. The amendment adds a mandate preamble, an emergency preamble and an emergency clause to the bill. The amendment changes the charter of the Kennebec Water District. Currently, the board of trustees of the district is made up of 7 trustees, one of whom alternates between Vassalboro and Benton. Under this amendment the number of trustees is increased to 8 and Vassalboro and Benton each have a trustee on the board, but the trustees from Benton and Vassalboro each have only a 1/2 vote.

This bill proposed to change certain laws relating to the Public Utilities Commission. Several of these changes were incorporated into the committee amendment to LD 1268.
