**SUMMARY OF LEGISLATION BEFORE
THE JOINT STANDING COMMITTEES**

AUGUST 1995

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries. The publication, History and Final Disposition of Legislative Documents, is helpful in determining to which committee any particular bill was referred.

In this document, the committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number, together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various categories of final action are abbreviated as follows:

LD 675 **An Act to Require Disclosure of the Criminal History of a Juvenile That Moves into a Public Housing Project** ONTP

SPONSOR(S)	COMMITTEE REPORT	AMENDMENTS ADOPTED

SUMMARY

This bill would have authorized a criminal justice agency to release certain juvenile offense information to a public housing administrator for the administrator to share with the other residents of the public housing project when a juvenile with a juvenile offense record moved into or lived in the public housing project.

LD 682 **An Act to Require Employers to Pay the Cost of Recertification Training for Law Enforcement and Corrections Officers** ONTP

SUMMARY

This bill would have required that the employers of law enforcement officers and corrections officers pay the costs of in-service recertification training and in-service training, respectively.

SUMMARY

This bill would have provided a General Fund appropriation for a staff caseworker at the Maine Youth Center to provide counseling services to sex offenders.

COMMITTEE AMENDMENT "A" (H-170) was the majority report of the Joint Standing Committee on Criminal Justice. The amendment would have changed the amount to be allocated for fiscal year 1995-96 from \$34,195 to \$25,647 and would have also added a fiscal note to the bill.

LD 756 **An Act to Prohibit the Use of State Money and Personnel to Conduct Warrantless Searches by Helicopters** ONTP

SUMMARY

This bill would have prohibited the Maine Drug Enforcement Agency, the Maine National Guard and all other law enforcement agencies from using helicopters without a search warrant and probable cause to believe that marijuana was being grown on the property to be surveyed.

COMMITTEE AMENDMENT "A" (H-226) was the minority report and would have clarified that the overflight limitations apply only to helicopter operations to locate marijuana.
