**SUMMARY OF LEGISLATION BEFORE
THE JOINT STANDING COMMITTEES**

AUGUST 1995

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries. The publication, History and Final Disposition of Legislative Documents, is helpful in determining to which committee any particular bill was referred.

In this document, the committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number, together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various categories of final action are abbreviated as follows:

HOUSE AMENDMENT "A" TO COMMITTEE AMENDMENT "A" (H-486) adds uncontrolled tire stockpiles to the list of sites and facilities to which a person may not add used motor vehicle tires.

LD 770 **An Act to Return to Municipalities Control over Permits by Rule Currently Implemented by the Department of Environmental Protection** **ONTP**

SPONSOR(S) **COMMITTEE REPORT** **AMENDMENTS ADOPTED**

SUMMARY

This bill would have made municipalities the sole enforcement authority for civil violations of permit-by-rule standards.

LD 773 **An Act to Amend the Laws Pertaining to the Control of Phosphorus Transport in Watersheds** **ONTP**

SPONSOR(S) **COMMITTEE REPORT** **AMENDMENTS ADOPTED**

SUMMARY

This bill would have required that any method developed to determine phosphorus concentration in great pond watersheds incorporate a methodology that accounts for the distance of a subdivision from the great pond in addition to the characteristics of land that influence a subdivision's impact on phosphorus concentrations.

LD 776 **Resolve, to Require the Department of Environmental Protection to Restore Daigle Pond** **ONTP**

SPONSOR(S) **COMMITTEE REPORT** **AMENDMENTS ADOPTED**

SUMMARY

This resolve would have required the Department of Environmental Protection to use funds from the Lake Restoration and Protection Fund to implement the proposal of the Committee for Daigle Pond Restoration to restore Daigle Pond in the Town of New Canada.

LD 817 **An Act to Establish a System of Recycling Credits for Processed Wood Products** **ONTP**

SPONSOR(S) **COMMITTEE REPORT** **AMENDMENTS ADOPTED**

SUMMARY

This bill would have allowed the use of processed wood products as mulch or as fuel for meeting recycling goals established by law.
