**SUMMARY OF LEGISLATION BEFORE  
THE JOINT STANDING COMMITTEES**

**AUGUST 1995**

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries. The publication, History and Final Disposition of Legislative Documents, is helpful in determining to which committee any particular bill was referred.

In this document, the committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number, together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various categories of final action are abbreviated as follows:

**LD 749**      **An Act to Prohibit Any State or Independent Agency  
from Establishing Private Accounts**

**SUMMARY**

This bill creates a separate section for the establishment of conference fee accounts and makes improper expenditures from these accounts punishable under the Maine Revised Statutes, Title 17-A, section 362.

COMMITTEE AMENDMENT "A" (S-151) replaces section 2 of the bill. The amendment creates a new Class E crime and clarifies restrictions on the use of fees. The amendment also adds a fiscal note to the bill.

HOUSE AMENDMENT "A" TO COMMITTEE AMENDMENT "A" (H-454) requires a state agency that conducts a conference, workshop or seminar for which fees are charged to establish an account for the sole purpose of receiving and expending these fees for the operation of the conference, workshop or seminar. The amendment provides that any item, equipment or other property purchased from the capital expenditures category of a conference fee account is state property.

**SUMMARY**

This bill allows the Governor to assign approval of emergency purchases to appropriate officials. The bill also allows for sole-source procurement in circumstances where the cost of the competitive bid process creates hardship and delay to affected agencies.

**SUMMARY**

This resolution proposes to amend the Constitution to allow the Legislature or a committee of the Legislature to disapprove agency rules adopted pursuant to a legislative delegation of authority.

**SUMMARY**

This bill establishes the Interim Office on Volunteerism within the Executive Department and directs the Governor to designate a state volunteer organization as that office. Reimbursement and expenses are not authorized for the Interim Office on Volunteerism and the office is subject to a sunset provision that is effective September 1, 1997.
