**SUMMARY OF LEGISLATION BEFORE
THE JOINT STANDING COMMITTEES**

AUGUST 1995

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries. The publication, History and Final Disposition of Legislative Documents, is helpful in determining to which committee any particular bill was referred.

In this document, the committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number, together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various categories of final action are abbreviated as follows:

SUMMARY

This resolve creates a Teacher Retirement Advisory Committee to examine the issue whether extracurricular stipends should be included or excluded from earnable compensation for teacher retirement purposes.

COMMITTEE AMENDMENT "A" (H-311) eliminates the legislator members of the Teacher Retirement Advisory Committee and strikes the provisions of the resolve providing reimbursement of those members. The amendment also clarifies the charge to the committee and adds a fiscal note to the resolve.

HOUSE AMENDMENT "A" TO COMMITTEE AMENDMENT "A" (H-434) clarifies that members of the Teacher Retirement Advisory Committee are not entitled to receive compensation or reimbursement for expenses.

SUMMARY

This bill would have amended the definition of "employment" for purposes of the laws governing unemployment compensation to specifically exclude services performed by prisoners participating in a work release program.

LD 1056 Resolve, to Create an Advisory Committee to Assist in the Funding of State Employee Workers' Compensation Claims

SUMMARY

This resolve creates an advisory committee to review the current method of funding workers compensation costs for state employees and make recommendations to the Governor and the Legislature on the best way to fund those costs consistent with fiscal responsibility, efficiency and public accountability. The advisory committee is required to report its recommendations to the Second Regular Session of the 117th Legislature. This bill was carried over to the Second Regular Session.
