**SUMMARY OF LEGISLATION BEFORE  
THE JOINT STANDING COMMITTEES**

**AUGUST 1995**

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries. The publication, History and Final Disposition of Legislative Documents, is helpful in determining to which committee any particular bill was referred.

In this document, the committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number, together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various categories of final action are abbreviated as follows:

**SUMMARY**

This resolve would have authorized Glenn Greenhalgh to sue the State and individual past and present employees of the Department of Human Services who are covered by a liability insurance policy or policies. The resolve would have authorized Glenn Greenhalgh to recover damages up to \$750,000 arising from erroneous claims of child abuse and the separation from his children by the department and its employees.

COMMITTEE AMENDMENT "A" (H-355) would have removed the authorization to sue individual past or present employees of the State and placed a cap of \$75,000 on the award of damages. The amendment would have also added a fiscal note to the bill.

This bill would have allowed candidates for state or federal office to limit voluntarily the amount of money they spend on a campaign to a maximum of 50¢ per registered voter.

H-330

**SUMMARY**

This bill allowed hotels on islands that are part of mainland municipalities to have the island population count as a true measure of population, rather than including the mainland population.

COMMITTEE AMENDMENT "A" (H-330) corrected existing language to conform with the 1993 statutory change that moved the responsibility of liquor licensure to the Bureau of Liquor Enforcement; clarified that minors are excluded from hotel lounges that serve alcoholic beverages but not other function rooms; and kept the original provision of the bill that based the formula for granting a hotel liquor license on the population of the island, not the larger mainland municipality of which it was a part. It also added a fiscal note to the bill.

This bill would have eliminated state and agency liquor stores, but would have continued the state regulation of liquor stores operated by private persons and the state regulation of wholesaling of liquor.
