**SUMMARY OF LEGISLATION BEFORE  
THE JOINT STANDING COMMITTEES**

**AUGUST 1995**

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries. The publication, History and Final Disposition of Legislative Documents, is helpful in determining to which committee any particular bill was referred.

In this document, the committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number, together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various categories of final action are abbreviated as follows:

**LD 1132**      **An Act to Provide Increased Enforcement of Noise Pollution Laws**      **ONTP**

**SUMMARY**

This bill would have prohibited the operation of a motor boat that exceeds the same noise limit established in law for snowmobiles and airmobiles. The bill also would have prohibited a person from modifying a motorboat so that its noise emissions are louder than those emitted by the motorboat as originally constructed. Exceptions are made for the 48-hour period before and after a race or regatta approved by the Commissioner of Inland Fisheries and Wildlife.

**LD 1157**      **Resolve, to Require the Department of Inland Fisheries and Wildlife to Remove Deer from Marsh Island**      **ONTP**

This resolve would have required the Department of Inland Fisheries and Wildlife to remove enough deer from Marsh Island.

**SUMMARY**

This bill increases the moose hunting permit fee to \$300 for nonresidents and aliens and increases the application fee for a moose hunting permit to \$20 for nonresidents and aliens.

COMMITTEE AMENDMENT "A" (H-263) adds a fiscal note to the bill.

SENATE AMENDMENT "A" TO COMMITTEE AMENDMENT "A" (S-205) adds an appropriation section to the bill and replaces the fiscal note.

**LD 1181**      **An Act to Establish a Moose Lottery Point System**      **ONTP**

**SUMMARY**

This bill would have required the Department of Inland Fisheries and Wildlife to change the moose lottery so that applicants who were unsuccessful in previous lotteries have a better chance of winning.
