SUMMARY OF LEGISLATION BEFORE THE JOINT STANDING COMMITTEES

AUGUST 1995

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries. The publication, <u>History and Final Disposition of Legislative Documents</u>, is helpful in determining to which committee any particular bill was referred.

In this document, the committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number, together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various categories of final action are abbreviated as follows:

SUMMARY

This bill amends the laws regarding false claims for payment or approval by the Department of Human Services to clarify that violators of these laws pay civil penalties, not damages. This bill also enables the State to seek the costs of investigation and attorney's fees from violators of these laws.

SENATE AMENDMENT "A" (S-147) adds a fiscal note to the bill.

SUMMARY

This bill modifies the definition of "health care facility" under the Maine Certificate of Need Act of 1978 to include rural health clinics, a term that is also defined in the bill to include certain clinics in rural areas designated as shortage areas. The bill also clarifies that health care facilities under the certificate of need laws are those that must obtain a certificate of need in accordance with state laws and rules.

SUMMARY

This bill amends the laws regarding HIV testing. If a victim of a crime or an alleged crime involving a sexual act, as defined in the Maine Revised Statutes, Title 17-A, section 251, requests an HIV test, a health care facility that performs HIV tests must offer the required pretest counseling and perform the test. This bill requires an alleged or convicted perpetrator of crimes involving a sexual act to undergo HIV testing if requested by the victim and if there is good cause to believe that the victim may have been exposed to the blood or body fluids of the perpetrator.
