**SUMMARY OF LEGISLATION BEFORE
THE JOINT STANDING COMMITTEES**

AUGUST 1995

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries. The publication, History and Final Disposition of Legislative Documents, is helpful in determining to which committee any particular bill was referred.

In this document, the committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number, together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various categories of final action are abbreviated as follows:

6. The bill would have required the Maine Elections and Ethics Commission to provide recommendations for additional provisions concerning audits, accountability and sanctions to be presented to the Legislature for adoption or disapproval.

The minority COMMITTEE AMENDMENT "A" (H-354) would have added an allocation section and a fiscal note to the bill.

LD 1303 **An Act to Clarify Definitions Under the Laws Concerning Games of Chance** CARRIED OVER

SUMMARY

This bill clarified the definitions of game of chance and game of skill. This bill was carried over until the second session.

LD 1327 **An Act to Expand Eligibility for the Maine Veterans' Homes** PUBLIC 211

SPONSOR(S) **COMMITTEE REPORT** **AMENDMENTS ADOPTED**

SUMMARY

This bill provided that, for purposes of admission into Maine Veterans' Homes, eligible veterans included persons on active duty at any time during the period from December 22, 1961 to August 5, 1964.

LD 1373 **An Act to Prohibit Fairs from Restricting Simulcasting at Off-track Betting Parlors** ONTP

SPONSOR(S) **COMMITTEE REPORT** **AMENDMENTS ADOPTED**

SUMMARY

This bill would have removed the statutory provisions that gave a noncommercial racing licensee the authority to prohibit an off-track betting parlor from simulcasting racing events when the licensee is running races.

LD 1377 **An Act to Require That Campaign Finance Reports Be Archived** ONTP

SPONSOR(S) **COMMITTEE REPORT** **AMENDMENTS ADOPTED**

SUMMARY

This bill would have required that the Commission on Governmental Ethics and Election Practices establish a retention schedule for campaign reports filed with them. The retention period could not have been less than 25 years.
