SUMMARY OF LEGISLATION BEFORE THE JOINT STANDING COMMITTEES

AUGUST 1995

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries. The publication, <u>History and Final Disposition of Legislative Documents</u>, is helpful in determining to which committee any particular bill was referred.

In this document, the committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number, together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various categories of final action are abbreviated as follows:

SUMMARY

This resolve restores funding to the Department of Human Services, Bureau of Health for family planning services that was deappropriated in fiscal year 1994-95. It also establishes a 2-year demonstration project to train 8 recipients of Aid to Families with Dependent Children to work with families in that program to increase their voluntary use of family planning services to improve readiness for job training and placement in the workforce.

SUMMARY

This bill makes single-serving snack foods ineligible for purchase with food stamps. This bill also allows food stores and other stores authorized to participate in the federal food stamp program to receive automatic authorization as Women, Infants and Children Special Supplemental Food Program vendors upon filing requests with the Department of Human Services.

SUMMARY

This bill amends Project Opportunity by: requiring mandatory participation by recipients of AFDC; expanding the project to statewide participation; and prohibiting an increase in AFDC benefits because of an increase in family size to participants for a child that was conceived after eligibility was determined.

This bill also requires the Department of Labor and the Department of Human Services to work together to create an employment program to replace AFDC. Minimum criteria are enumerated.
