**SUMMARY OF LEGISLATION BEFORE
THE JOINT STANDING COMMITTEES**

AUGUST 1995

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries. The publication, History and Final Disposition of Legislative Documents, is helpful in determining to which committee any particular bill was referred.

In this document, the committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number, together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various categories of final action are abbreviated as follows:

**LD 1335 An Act to Amend Laws Pertaining to On-premises Signs
by Allowing for Changeable Signs**

SUMMARY

This bill proposed to clarify the types of animated or moving signs that are prohibited in law and exempts from the prohibition those signs on which the display or message, although electronically illuminated or mechanically driven, does not appear to move.

COMMITTEE AMENDMENT "A" (H-456) replaces the original bill. The amendment allows for changeable message board signs where the message can change once every 4-hour period.

SUMMARY

This bill as amended by COMMITTEE AMENDMENT "A" (H-388) allows the Secretary of State to waive the skill and road tests for an applicant for a school bus operator endorsement if the applicant has a valid authorization from another state to operate a school bus. The amendment clarifies that the applicant must satisfy all other requirements for issuance of a school bus operator endorsement.

SUMMARY

This bill amends the Maine Turnpike Authority's budget for calendar year 1995.

The authority's turnpike revenue bonds, Series 1994, were issued July 7, 1994 in the amount of \$73,130,000 to pay the State for the reacquisition of portions of Interstate 95 from the Department of Transportation to fund bridge rehabilitation and other construction and safety projects and to fund the authority's electronic toll conversion project. The new bonds require an increase in the debt service allocation for 1995 to a total of \$6,844,111.

SUMMARY

This bill would have allowed an application for a certificate of title to be submitted to the branch offices of the Bureau of Motor Vehicles. Unless the Secretary of State believed that a problem existed with the application or the applicant, the certificate could be issued immediately by the office receiving the application.
