**SUMMARY OF LEGISLATION BEFORE
THE JOINT STANDING COMMITTEES**

AUGUST 1995

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries. The publication, History and Final Disposition of Legislative Documents, is helpful in determining to which committee any particular bill was referred.

In this document, the committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number, together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various categories of final action are abbreviated as follows:

SUMMARY

This bill repeals the Local Government Records Board and transfers the work to the Archives Advisory Board, which is already functioning to make retention recommendations about State Government records.

COMMITTEE AMENDMENT "A" (H-197) corrects a technical error in the bill presented on behalf of the Committee on Bills in Second Reading.

SUMMARY

This bill has been carried over to the second regular session. This bill provides a mechanism in which agencies in State Government would be required to identify and assess the impact of any federally mandated program and identify those provisions inconsistent with state laws. It also requires that a state agency consider the cost of the mandate as well as the impact on the State's citizens when developing policies in response to a federal mandate.
