**SUMMARY OF LEGISLATION BEFORE
THE JOINT STANDING COMMITTEES**

AUGUST 1995

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries. The publication, History and Final Disposition of Legislative Documents, is helpful in determining to which committee any particular bill was referred.

In this document, the committee report or reports, the prime sponsor for each bill and the lead co-sponsor in each house if one has been designated are listed below each bill title. All adopted amendments are listed, by paper number, together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various categories of final action are abbreviated as follows:

LD 1456 An Act to Further Encourage Electric Rate Stabilization

SUMMARY

This bill increases the authority of the Finance Authority of Maine to issue loans to electric utilities to fund agreements with qualifying facilities that reduce the costs to the utility and benefit the ratepayers. This bill proposed to increase from \$100,000,000 to \$200,000,000, the amount in bonds that may be issued for loans. An additional \$40,000,000 in bonds was proposed to be allowed to be issued to fund capital reserve funds. The bill extends, from May 1, 1995 to February 1, 1996, the period during which loans may be made.

COMMITTEE AMENDMENT "A" (H-229), which was the majority report of the committee, increases the amount in bonds that may be issued for loans by the Finance Authority of Maine for electric rate stabilization projects from the \$200,000,000 proposed in the bill to \$220,000,000. It also increases the amount of bond proceeds that may be used to fund capital reserve funds from the \$40,000,000 proposed in the bill to \$44,000,000. This amendment increases the period in which the Public Utilities Commission must issue or deny a certificate approving a utility proposal to enter into an electric rate stabilization agreement from 30 days to 60 days. This amendment makes technical changes and adds a fiscal note.

SUMMARY

This bill is the Public Utilities Commission's 1995 housekeeping bill and makes nonsubstantive changes to laws regulating utilities.

The bill replaces the outdated terms "tariff" and "general order" with "schedule" and "rule," respectively, corrects cross references and replaces references to the now defunct Office of Energy Resources with references to the State Planning Office.

COMMITTEE AMENDMENT "A" (H-307) separates 2 relatively unrelated provisions of law into 2 subsections in order to increase clarity.
